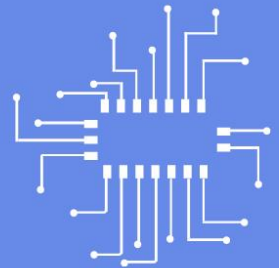

Das Projekt

VOIS Erasmus+ KA2, VET, ist ein europäisch finanziertes Projekt zum Aufbau professioneller offener Innovationskompetenzen im Agrar- und Ernährungssektor und in der Bioökonomie.

Was bisher geschah:

The project has just entered the 3rd and final year of its life. The VOIS partnership has developed a comprehensive Virtual Open Innovation Environment allowing SMEs to effectively improve their OI competencies and their ability to implement open innovation in their firms. This consists of 3 areas with opportunities for SMEs to enhance their competencies:

- **Area 1 – Capacitation for Organisational Open Innovation focused on open innovation strategies/methodologies for SMEs and capacitating participants to design and implement them in their organisations**
- **Area 2 – Managers’ Development Area focused on the development of individual Open Innovation Competencies required when managing activities in the scope of open innovation**
- **Area 3 – Open Innovation Repository – a database about open innovation gathering tools already available and support measures for SMEs. It covers the target sector across all engaged countries and on EU level.**

What’s next?

The partnership has already implemented an internal piloting/testing phase with the aim of spotting and resolving any errors and mistakes with regards to the content of the training material.

The next step includes the external piloting phase that will be carried through each partner country with the assistance of members of the target groups in order to ensure the quality, relevance and usability of the developed learning resources.
